- (ii) Overall twelve years of experience in Defence, Police, Home Guards and Civil Defence Organizations at the Centre or State level.

Note 1.-The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration of appointment on deputation. Similarly, deputationists shall not be eligible for appointment by promotion.

Note 2.-The Period of deputation(including short term contract) (including period of deputation) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not to exceed four years.

Note 3.- The maximum age limit for appointment by deputation shall be not exceeding fifty-six years as on the closing date of receipt of applications.

For Ex-Servicemen

Deputation (Including Short Term Contract) or Reemployment

Armed Forces personnel in the rank of Colonel in Indian Army or Navy or Air Force in Level-13 in the pay matrix (Rs.1,23,100-2,15,900), who are due to retire or to be transferred to reserve within a period of one year and have the qualifications and experience prescribed for deputation shall also be considered. If selected such officers will be given deputation terms upto the date on which they are due for release from the Armed Forces. Thereafter. they may be continued on re-employment terms. In case such eligible officers have retired or have been transferred to reserve before the actual selection to the post is made, their appointment will be on re-employment basis (Re-employment upto the age of superannuation with reference to civilian post).
