OFFICE MEMORANDUM

Subject:- Advance release of Central share from State Disaster Risk Management Fund (SDRMF) for the year 2020-21.

The undersigned is directed to state that vide this Ministry's letter No. 33-4/2020-NDM-I, dated 14th March 2020, by way of a special one time dispensation, the Government has decided to treat COVID-19 as a notified disaster for the purpose of providing assistance under SDRF on (i) Measures for quarantine for sample collection and screening (ii) Procurement of essential equipments/ labs for response to COVID-19. Further on 28th March use of SDRF was allowed for relief measures - provision for temporary accommodation, food, clothing, medical care etc. in relief camps, under the existing guidelines and norms of SDRF.

2. With a view to make adequate fund available to the State Governments for effective response for containing the spread of COVID-2019 outbreak in the country, as a special dispensation, as per the existing SDRF guidelines/ norms, it has been decided with the approval of Hon'ble Home Minister, to recommend release of the 1st installment of Central share of SDRMF, in advance, for the current financial year 2020-21, to all the State Governments, as per details given at Annexure. It is also decided to extend the validity of existing guidelines and norms of SDRF for a further period of one year or till such time new guidelines/norms are framed, whichever is earlier.

3. The Department of Expenditure (Ministry of Finance) is, therefore, requested to kindly release the aforesaid installment of current financial year 2020-21, in advance, to all the State Governments to enable them to carry out effective containment measures of COVID-2019 virus outbreak in the country, under intimation to this Ministry.
