Subject:- Filling up the post of Fire Adviser in the O/o. Director General (Fire Service, Civil Defence & Home Guards) under Ministry of Home Affairs.

Sir/Madam,

The Ministry of Home Affairs requires the services of a suitable officer for the post of Fire Adviser in the O/o. Director General (FS, CD & HG), in the Ministry of Home Affairs in level-13 on deputation basis (Including Short Term Contract)/Promotion.

2. The post is a General Central Service, Group A Gazetted, Non-Ministerial in Level 13 (Rs.123100-215900/-) plus usual allowances as admissible. Pay of the officer selected would be fixed as per the existing instructions of the Department of Expenditure, Ministry of Finance. The Headquarters will be at New Delhi but the officer selected would be liable to serve anywhere in India.

3. Following eligibility criteria is prescribed for filling up the post:

Officers of the Fire Brigades of the Central/State Governments/Municipal Corporation/Public Sector Undertakings: -

- (a) (i) holding analogous posts on regular basis, or
(ii) in Pay Band 3, Rupees 15600-39100 with grade pay of Rs.7600 (pre-revised) with five years regular service in the grade; or
(iii) in Pay Band 3 Rupees 15600-39100 with grade pay of Rupees 6600 with ten years' regular service in the grade; and

Note 1: Departmental officer namely, Deputy Fire Adviser with ten years' regular service in that grade shall also be considered along with outside candidates and if selected for appointment to the post, shall be treated as having been filled by promotion.

Note 2: (Period of deputation (ISTC) including period of deputation (ISTC) in another Ex-cadre post held immediately preceding this appointment in the

same or some other organization / department ordinarily not to exceed four years. The maximum age limit for appointment by deputation (ISTC) shall not be exceeding 56 years as on the closing date of receipt of applications.

Note 3: For the purpose of appointment on deputation/absorption basis, the service rendered on a regular basis by an officer prior to 1st January, 2006 (The date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding Grade Pay/Pay scale extended based on the recommendations of the pay commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common Grade Pay/Pay Scale, and where this benefit will extend only for the post(s) for which that Grade Pay/Pay scale is the normal replacement grade without any up-gradation.

- (b) Possessing the educational qualifications and experience as under:
- (i) Bachelor's degree in Fire Engineering from a recognized University.
 - (ii) Twelve years experienced in Fire Service in Government or local bodies or public sector undertaking, out of which five years' regular service in Pay Band 3 with grade pay of Rs.6600.

Note 1: Qualifications are relaxable at the discretion of the Union Public Service Commission, for reasons to be recorded in writing, in the case of candidates otherwise well qualified.

Note 2: The qualifications regarding experience is relaxable at the discretion of the UPSC in the case of candidates belonging to scheduled castes and scheduled tribe, if, at any stage of selection, the UPSC is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

4. A copy of the existing Recruitment Rules for the post of Fire Adviser in the O/o. Director General (FS, CD & HG) under the Ministry of Home Affairs is enclosed.

5. Officers who volunteer and are sponsored by their Ministry/Department/State Governments/UTs Administration etc. for the post will not be permitted to withdraw their names later.

6. It is requested to give wide circulation to these vacancies among all PSUs/Semi-Govt. Organizations/Statutory/Autonomous Organization/Recognized Research Institute/Universities under your administrative control. The nominations of eligible officers along with their applications (in duplicate) duly countersigned by the competent authority in the enclosed proforma along with Annual Confidential Reports/APARs in original or their attested copies duly



attested with rubber stamp on each page by an officer not below the rank of Under Secretary for the last five years of the officer who could be spared immediately in the event of their selection may be sent to the **Director General (Fire Services, Civil Defence & Home Guards), O/o. Director General (Fire Service Civil Defence & Home Guards) Government of India, Ministry of Home Affairs, East Block-7, Level-7, R. K. Puram, New Delhi-110066** within 60 days of the date of issue of this circular. While forwarding the names, an integrity certificate and a certificate that no disciplinary action/proceedings, vigilance case is either pending or being contemplated against the officer may also be attached.

7. Applications received after the last date or applications incomplete in any respect or those not accompanied by the document/information mentioned in para 6 above will not be considered. The application forwarding authorities may ascertain that the particulars sent in respect of the officer are correct as per their service record.

सा.का.नि.55—राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए और गृह मंत्रालय अग्निशमन सलाहकार भर्ती नियम, 1990 को उन बातों के सिवाय अधिकांश करते हुए, जिन्हें ऐसे अनिक्रम्य से पहले किया गया है या करने का लोप किया गया है, गृह मंत्रालय में अग्निशमन सलाहकार के पद पर भर्ती की पद्धति का विनियमन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात्:-

1. संक्षिप्त नाम और प्रारंभ.-

- (1) इन नियमों का संक्षिप्त नाम गृह मंत्रालय, अग्निशमन सलाहकार भर्ती नियम, 2016 है।
- (2) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।

2. पद संख्या, वर्गीकरण वेतनमान.-

पद संख्या उसका वर्गीकरण, वेतन बैंड और ग्रेड वेतन या वेतनमान वह होगा जो इन नियमों से उपाबद्ध अनुसूची के स्तंभ (2) से स्तंभ (4) में विनिर्दिष्ट है।

3. भर्ती की पद्धति, आयु-सीमा, और अर्हताएं आदि : उक्त पद पर भर्ती की पद्धति, आयु-सीमा, अर्हताएं और उससे संबंधित अन्य बातें वे होंगी जो उक्त अनुसूची के स्तंभ (5) से स्तंभ (13) में विनिर्दिष्ट है।

5. शिथिल करने की भाक्ति.- जहां केन्द्रीय सरकार की यह राय है कि ऐसा करना आवश्यक या समीचीन है, वहां वह उसके लिए जो कारण हैं उन्हें लेखबद्ध करके तथा संघ लोक सेवा आयोग से परामर्श करके, इन नियमों के किसी उपबंध को किसी वर्ग या प्रवर्ग के व्यक्तियों की बाबत, आदेश द्वारा शिथिल कर सकेगी।

3. व्यावृत्ति.- इन नियमों की कोई बात ऐसे आरक्षण, आयु-सीमा में छूट और अन्य रियायतों पर प्रभाव नहीं डालेगी जिनका केन्द्रीय सरकार द्वारा इस संबंध में समय-समय पर निकाले गए आदेशों के अनुसार अनुसूचित जातियों, अनुसूचित जनजातियों, भूतपूर्व सैनिकों और अन्य विशेष प्रवर्ग के व्यक्तियों के लिए उपबंध करना अपेक्षित है।

MINISTRY OF HOME AFFAIRS

New Delhi, the 8th April, 2016

G.S.R.55—In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the Ministry of Home Affairs, Fire Adviser Recruitment Rules, 1990, except as respect things done or omitted to be done before such supersession, the President hereby makes the following rules, regulating the method of recruitment to the post of Fire Adviser in the Ministry of Home Affairs, namely :-

1. Short title and commencement. -
 (1) These rules may be called the Ministry of Home Affairs, Fire Adviser Recruitment Rules, 2016.
 (2) They shall come into force on the date of their publication in the Official Gazette.
2. Number of post, classification, pay band and grade pay or pay scale. -
 The number of post, its classification pay band and grade pay or pay scale attached there to shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
3. Method of recruitment, age limit and qualifications, etc.-
 The method of recruitment to the said post, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
4. Disqualification. - No person,
 (a) who has entered into or contracted a marriage with a person having a spouse living; or
 (b) who, have a spouse living, has entered into or contracted a marriage with any person,
 shall be eligible for appointment to the said posts;

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for doing so, exempt any person from the operation of this rule

power to relax :- Where the Central Government is of the opinion that it is necessary or expedient to do so, it may by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving :- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen, and other special categories of persons, in accordance with orders issued by the Central Government from time to time in this regard.
