Administrative Note for 3rd National Platform for Disaster Risk Reduction (to be held on 5-6 May 2020)

1. Introduction

- This note provides general information on administrative and logistic arrangements pertaining to Third Meeting of National Platform on Disaster Risk Reduction (NPDRR 2020). The event will be hosted by the Ministry of Home Affairs, Government of India during 5-6 May 2020 in collaboration with NDMA, NIDM and NDRF.
- The Government of India has constituted a multi-stakeholder National Platform for Disaster Risk Reduction (NPDRR) vide Government's Resolution dated 26th February 2013 under the Hon'ble Union Home Minister as Chairperson and Minister of State in-charge of Disaster Management in the Ministry of Home Affairs(MHA) as Vice Chairperson of NPDRR. The resolution was subsequently revised and a comprehensive resolution dated 5th July 2017 was notified followed by an amendment dated 03.09.2019.

2. Venue

- The venue of the T h i r d M e e t i n g o f N P DRR will be at the Vigyan Bhawan, New Delhi, a premier convention centre of the Government of India in New Delhi.
- The Conference H alls are equipped with audio-video facilities of global standards including local area network facilities for internet users. Vigyan Bhawan has connectivity with all major roads of New Delhi and can be accessed by bus, taxi and other local means of transportation. The nearest Metro Station is Udyog Bhawan, Maulana Azad Road, New Delhi.
