Cyclonic Storm 'Mekunu' over Oman Sub:

The Cyclonic Storm 'Mekunu' over Oman moved north-northwestwards with a speed of 10 Kmph during past 06 hours and lay centered at 1730 hours IST of today, 26th May, 2018 over Oman near latitude 18.3°N and longitude 53.0° E, about 180 km northwest of Salalah. It is very likely to move northwestwards and weaken into a Deep Depression during next 03 hours and further into a Depression during subsequent 03 hours.
