Sub: Extremely Severe Cyclonic Storm (ESCS) 'Mekunu' weakened into Very Severe Cyclonic

Storm

The Extremely Severe Cyclonic Storm 'Mekunu' over Oman moved further northwestwards with a speed of 12 Kmph during past 06 hours, weakened into a Very Severe Cyclonic Storm and lay centered at 0230 hours IST of today, 26<sup>th</sup> May, 2018 over Oman near latitude 17.1°N and longitude 53.5E, about 60 km west southwest of Salalah.
